## 2025 Seasonal Power Cart Rental Agreement

I ----- agree to rent a motorized golf cart for the sum of \$----- for the 2025 golf season. This cart is for my personal use only. Charging for the use of the cart to anyone else is strictly prohibited. If I charge any money for the use of my power cart, my privileges will be forfeited, and this agreement will be terminated. All seasonal power cart members must report the cart number to the pro shop and return all keys to the pro shop in a timely manner. Seasonal power cart use will expire in October 2025.

### This Seasonal Power Cart Agreement gives me the following privileges:

1. To reserve a power cart at the time of booking
2. The use of a power cart whenever I come to play golf (except when course conditions are not suitable for power cart usage or when tournament bookings require the full use of the golf cart fleet.)
3. Party of 4 requires sharing two carts.

### MANAGEMENT RESERVES THE RIGHT TO CANCEL THIS POWER CART AGREEMENT AT ANY TIME.

For and in consideration of the rental of the power cart to me, I agree to return the power cart to the pro shop immediately following my completion of 18 holes, as in good condition as when I received the cart. I agree to pay for any damages that are sustained to the cart and the property while in my custody, care or control. I further agree to hold Bowmanville Golf and Curling Ltd. Free and harmless from damage of any nature whatsoever that may arise while the motorized cart is in my possession. I represent that I am familiar with the operation and use of the above golf cart and have read the instructions, and that I can operate and control the same in accordance with the said instructions. Power carts must stay in the rough, follow all cart signs, remain 30 feet from greens and tees, and stay on the cart path where provided. All riders must be of the age of 8+ years by regulation of Ontario R21407.

I UNDERSTAND THAT ALL OPERATORS OF THE POWER CART MUST BE 18 YEARS OF AGE AND HAVE A VALID (G) DRIVERS LICENSE.
